## **Bill to Correct the RUSA Elections Code**

*Whereas*, the Assembly Election Code provides all the rules and regulations in which an election is carried out by RUSA;

*Whereas,* in Amendment IV, Section B, Clause 2, of said aforementioned document, it states that "The spring election period must end by the first of April.";

*Whereas*, the previously mentioned date did not properly account for the timeline of future semesters at Rutgers University;

*Whereas*, for the current timeline of the spring elections for this semester involves it extending past this date,

*Whereas*, the only means in which elections would be able to take place in a timely and organized manner is if the hard date for April first was nullified,

*Be it hereby resolved*, that voting for the RUSA Spring Elections have to conclude prior to the last four possible meeting dates of the spring semester;

*Be it further resolved*, that the remaining four meeting dates will function as follows: one meeting will be dedicated to the departing Assembly to have one last session, one meeting will function as the State of the Assembly for the newly elected representatives, and the last two meeting dates will function as two regular RUSA meetings for the newly elected assembly to ensure that they are able to elect all executive board positions.

## Therefore, be it enacted by the Assembly:

A. Amendment IV, Section B, Clause 2 of the Elections code be amended to:

2. The springelection period must conclude prior to the last four possible meeting dates of the spring semester and in addition the remaining four meeting dates will function as follows: one meeting will be dedicated to the departing Assembly to have one last session, one meeting will function as the State of the Assembly for the newly elected representatives, and the last two meeting dates will function as two regular RUSA meetings for the newly elected assembly to ensure that they are able to elect all executive board positions.
