### **RUSA Elections Committee**

The Elections Committee is tasked with administering the Fall Elections based off of RUSA authoritative documents, including the Standing Rules and Elections Code, and enforce said rules of the elections. The Fall Elections Committee was chaired by 2019-2020 IA Chair **Ryed Jadun**, and the committee formed included four members: 2018-2019 IA Chair and 2018 Fall Elections Chair - **Alex Anderson**; Pharmacy Governing Council member - **Brian Ding**; Fall Elections Committee Member - **Cass Sicherer**; and Senate Student Affairs Co-Chair (and self-proclaimed *Friendship Czar*) - **Oluwatobi Omotoso**. As is generally the case with elections, RUSA President **Jhanvi Verani** had a search committee pick out the members of the Elections Committee with recommendations from the Fall Elections Chair.

The Elections Appeals Committee is tasked with interpreting the Elections Code and ruling on Appeals. The same process for selecting members of the Elections Appeals Committee was followed, except with recommendations from the Appeals Chair, RUSA Parliamentarian **Nicholas Tharney**, taken into account as well. The members of the Appeals Committee were: Big Ten Liaison - **Marc Younker**; and Engineering Governing Council Member - **Kaaviya Krishna Kumar**.

# **Elections Committee Resolutions and Initiatives**

### **Temporary Resolution 1**

Temporary Resolution 1 was a document created to establish a plan of action and timeline for the Fall 2019 Elections. The link in this section provides this document in its entirety.

### Resolution 1 Fall 2019 Elections

### Meetings

The Fall Elections Committee had a single meeting call on 8/18, where the topics of Elections Code, committee responsibilities, and timeline came up. Besides that preliminary meeting, all conversations and decisions were made through a Groupme chat and private messages. The link in this section provides all of the Meeting Minutes.

### **Fall Election Information Sessions**

Four Information Sessions with the goal of having as many Fall Elections Committee members as possible show up to as varied locations throughout the campuses as possible.

### Set Up

Slides were used to present relevant information to candidates and chips and water were provided as refreshments. Rooms were selected by the advisor Laura, and were chosen to be in the most visible places possible. The slides can be found <u>here</u>.

Slides were updated after each session to provide relevant information, namely to get rid of passed dates, to update the number of positions available after individuals dropped out, and to amend misinformation - such as that provided on one of the Senator slides (it was stated Senators do not have to be a part of general RUSA committees, however this is not the case).

### **Tabling Sessions**

Tabling Sessions were set up to spread info about the elections, and they brought in 68 votes according to the ballot poll. These sessions were initially completely voluntary, but due to the lack of tabling, they were made able to replace office hours for that week, and students were added in by the advisor in place of their office hours based off of their list of availabilities. As such, some locations/times were switched around due to students not knowing and having things come up at the times they were put in. The edited times can be found <u>here</u>.

### **Declaration Of Intent (DOI)**

The DOI was intended to open on 9/10 at 10am, however due to it not being published, it actually opened the next day, as soon as the issue was found. The DOI asked for Name, Class Year, Residing Campus, School, Cumulative GPA, Cell Phone, Email, Ticket Name, Personal Statement, Affirmation of Elections Code, and T-Shirt Size. The DOI can be found in Appendix A.

### **Voting Period**

The Voting Period was meant to open on September 30th at 12:00am and close on October 2nd at 11:59pm. However, the form opened 18 minutes late, and had to be closed 10 minutes into its opening due to some issues, and the closing date was extended to October 3rd at midnight due to Rosh Hashanah conflicting on two of the days during the voting period. The Ballot is provided in Appendix B.

### Issues

The Ballot had a number of mistakes upon the initial time of publication. The first issue came when the actual ballot was not published after completion, so the time it opened was 18 minutes late. On top of this, it was noted 10 minutes after the form actually opened that there were a small number of mistakes. The candidate Nikita Shankar had the wrong ticket name listed, which was promptly fixed from being "Rutgers United" to "Rutgers Rise". Vahini Shori was left off of the ballot since she had submitted the DOI late, but since the Chair decided that she could be added in so long as an appeals was made later for the Appeals Committee to decide on, she was added at that point. On top of this, 2023 reps Nina Gohil and Ameel Jani did not have their tickets listed, so that too was added. They were all fixed within the first 10 minutes of voting opening.

### Extension

An extension of 24 hours voting time was made to the voting period due to Rosh Hashanah conflicting with the majority of the originally set voting period. This was decided by the committee and relayed to all candidates and to all RUSA members on October 2nd at around 5pm. This also allowed an email to be sent by the secretary of RUSA urging all students to vote since there is only a day left.

### **Appeals Filed**

The Chair of the Elections Committee filed an appeal against senator candidate Vahini Shori due to her having not submitted the DOI form in time. Please read the Elections Appeals Committee Report for more information on this and other appeals. The report can be found here:

### **Remarks and Recommendations**

The process was mostly quick and efficient due to the predecessors and advisors knowing past procedure. The only obstacles and issues in hindsight can veritably be fixed and accounted for in the future. One glaring mistake was the DOI's formation being done by an eboard member of RUSA, who was also running, thus in the future only Elections Committee members should be allowed to create the DOI and anything else elections related. Also, the Chair of the Elections Committee allowed a candidate to join despite submitting the DOI late. This caused issues in the creation of the ballot, and was reported by the chair to the Appeals Committee, which then resulted in disqualification of the candidate. Finally, it is recommended that these two changes be made in future elections: ranked order voting be allowed, and endorsements should have a set deadline which is at least 24-hours prior to the voting period. With these in mind, there are many great recommendations made by the Spring 2019 Elections Report which should also further be considered.





### Referendum Concerning the Allocation of SAS Senators

Six (6) SAS student members of the University Senate are elected based on the campuses on which they reside (Busch, Livingston, Cook, Douglass, College Ave, and Off-Campus). Within the Senate, students are recognized by their academic school (School of Arts and Sciences, Rutgers Business School, School of Engineering, School of Environmental and Biological Sciences, etc.) and by their stakeholder group at the University (student, faculty, staff, etc.). RUSA would like to remove our requirement to allocate Senate positions to each campus to explore more purposeful position allocations. Voting in favor of this referendum means supporting the removal of the following text from the RUSA Constitution, Art. 5 §5.02: "School of Arts and Sciences University Senators shall be distributed evenly across campuses and Campus Caucuses." Voting against this referendum indicates supporting the status quo, with campus-specific SAS Senate positions.
