# The Justice Resolution of 2020

Whereas, in this time of great and righteous social and political upheaval, we must take action towards building a more just world;

Whereas, the institutional rot of white supremacy pervades throughout the justice system, and action must be taken towards dismantling oppressive systems;

Whereas, George Floyd, 1 Breonna Taylor, 2 Atatiana Jefferson, 3 Philando Castille, 4 Tamir Rice, 5 Rayshard Brooks,<sup>6</sup> Tanisha Anderson,<sup>7</sup> and many more Black men, women, and gender non-conforming individuals have fallen to the scourge of police violence;

Whereas, Black Americans are killed by police at a rate more than twice as high as that of white Americans:8

Whereas, Black communities face incredibly high rates of incarceration.<sup>9</sup>

*Whereas*, with approval of the Rutgers University Student Assembly (RUSA, or the Assembly) the Legislative Affairs Committee has authored the Report on the New Jersey Justice System;<sup>10</sup>

*Whereas*, the Report contains a number of policy recommendations to be pursued in the state legislature;

**Be it hereby resolved,** that the Report on the New Jersey Justice System -- including policy recommendations and proposed endorsements therein -- is hereby adopted by the Rutgers University Student Assembly;

**Be it further resolved,** that the Assembly charges the Legislative Affairs Committee with pursuing the implementation of the proposed policies outlined within the report;

*Be it finally resolved*, that the Legislative Affairs Committee is granted broad discretion towards seeking to implement the policies outlined within the report.

## Resolution to Create the Ad-Hoc Committee on the Scarlet Honor Council

*Whereas*, in the 2019-2020 Assembly, Parliamentarian emeritus Nicholas Tharney and former Internal Affairs Chair Ryed Jadun created the Subcommittee on Student Conduct to investigate student concerns on the Student Conduct Policy;

Whereas, the Scarlet Honor Council has expressed interest in working to merge their organization to the Rutgers University Student Assembly.

*Be it hereby enacted,* the Assembly creates the Ad-Hoc Committee on the Scarlet Honor Council (aka the SHC ad-hoc committee) with the express purpose of outlining a structure and proposing a merger between the SHC and RUSA;

**Be** it further enacted, this open ad-hoc committee will be open to the public, but voting members shall only be limited to official members of RUSA and the SHC;

**Be it further enacted,** the ad-hoc will have the following purposes, but shall not be limited to discuss only these topics:

- a. Discuss and create an outline for how the Rutgers University Student Assembly may oversee, merge with, or otherwise interact with the Scarlet Honor Council;
- b. Address how the judiciary of the Assembly may be modified in the course of having the Assembly oversee, merge with, or otherwise interact with the Scarlet Honor Council;

**Be it further enacted,** the chair of the ad-hoc committee shall be tasked with providing an update, when deemed necessary by the chair or ad-hoc committee, to the Strategic Planning & Sustainable Governance Ad-hoc Committee to ensure the voices of governing councils are heard;

**Be** it further enacted, the chair of the ad-hoc committee shall furnish a final list of voting members of the ad-hoc within one week of the passage of this bill;

**Be it further enacted,** the chair of this ad-hoc committee shall furnish Operating Rules to the ad-hoc committee and the Assembly within two weeks of formation of said ad-hoc committee;

**Be it further enacted,** Sean Tonra, after deliberation by and at the recommendation of the Internal Affairs Committee, shall be appointed as chair of the ad-hoc committee;

*Be it further enacted,* the number of voting members on the ad-hoc from RUSA shall be roughly equal to the number of voting members on the ad-hoc from the SHC;

**Be it further enacted,** the ad-hoc committee may segment their work into a two-pronged report. Those projects shall be:

- 1. A research report stipulating the full benefits and drawbacks of engaging in such a merger, both in regards to how it affects RUSA as well as the student population as a whole;
- 2. Potential merger plan(s) detailing how RUSA's Legislature, Judicial Council, Executive Committee will function alongside SHC, should the ad hoc decide to recommend such a merger;

**Be it further enacted,** that by a two-thirds vote of the Assembly, we hereby suspend Article IV Section 9(a) of the Standing Rules in order to allow non-voting members of RUSA or students outside of RUSA to serve as voting members of the ad-hoc committee;

**Be it finally enacted,** the ad-hoc committee shall furnish all required reports with the policy recommendations formed by the ad-hoc committee to the Executive Committee and the Assembly at least one week before the Spring Election voting period begins.
